








Figure.S5 Influence analysis of 11 studies on  $PM_{2.5}$  and the risk of cognitive

impairment




Figure.S6 Influence analysis of 7 studies on NO<sub>2</sub>/NO<sub>x</sub> and the risk of cognitive

impairment




Fig.S7 Funnel plot of the relative risk of  $PM_{2.5}$  exposure and cognitive impairment.

Each dot represents a different study




Fig.S8 Funnel plot of the relative risk of NO<sub>2</sub>/NO<sub>x</sub> exposure and cognitive impairment.
